SECTION 3 — HAZARDS IDENTIFICATION

Silvery, lustrous metal. Metal tarnishes in moist air. Odorless.

Known human carcinogen (IARC-1).

Highly toxic by ingestion and inhalation. Avoid breathing dust. Body tissue irritant.

Fire hazard in dust form. When heated to a high temperature, it emits toxic fumes of Cd.

SECTION 4 — FIRST AID MEASURES

Call a physician and seek medical attention for further treatment, observation, and support after first aid.

Inhalation: Remove to fresh air at once. If breathing has stopped, give artificial respiration immediately.

Eye or External: Immediately flush with fresh water for at least 15 minutes.

Internal: Rinse out mouth, give 1 to 2 cups of water or milk, and induce vomiting. Call a physician or poison control at once.

SECTION 5 — FIRE FIGHTING MEASURES

Noncombustible solid in bulk form, but fire hazard in dust form.

When heated to a high temperature, it emits toxic fumes of Cd.

Fire Fighting Instructions: Use a triclass, dry chemical fire extinguisher. Firefighters should wear PPE and SCBA with full facepiece operated in positive pressure mode.

SECTION 6 — ACCIDENTAL RELEASE MEASURES

Restrict unprotected personnel from the area. Sweep up the spill, place in a sealed bag or container, and dispose. Ventilate area and wash spill site after material pickup is complete. See Sections 8 and 13 for further information.

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Inorganic #1. Store with metals and metal hydrides.

Store in a cool, dry place. Store in a Flinn Saf-Stor can. Use and dispense in a hood.

SECTION 8 — EXPOSURE CONTROLS, PERSONAL PROTECTION

Avoid contact with eyes, skin, and clothing. Wear chemical splash goggles, chemical-resistant gloves, and chemical-resistant apron. Use ventilation to keep airborne concentrations below exposure limits. Always wear a NIOSH-approved respirator with proper cartridges or a positive pressure, air-supplied respirator when handling this material in emergency situations (spill or fire).

Exposure guidelines: PEL 0.2 mg/m³ (OSHA)
