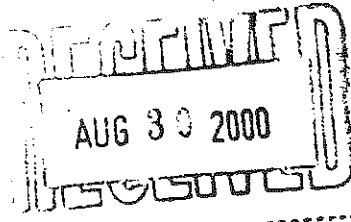

UNUSUAL FIRE AND EXPLOSION HAZARDS
