HAZARDS IDENTIFICATION

(ANSI Section 3)

Primary route(s) of exposure : Inhalation, skin contact, eye contact, ingestion.

Effects of overexposure:

- Inhalation: Irritation of respiratory tract. Prolonged inhalation may lead to. Inhalation of spray mist may cause irritation of respiratory tract. Mucous membrane irritation, fatigue, drowsiness, dizziness and/or lightheadedness, headache, uncoordination, nausea, vomiting, diarrhea, chest pain, coughing, central nervous system depression, intoxication, anesthetic effect or narcosis, difficulty of breathing, allergic response, tremors, pulmonary edema, pneumoconiosis, loss of consciousness, death. Possible sensitization to respiratory tract.
- Skin contact: Irritation of skin. Prolonged or repeated contact can cause dermatitis, defatting, allergic response, severe skin irritation. Possible sensitization to skin. Skin contact may result in dermal absorption of component(s) of this product which may cause fatigue, dizziness and/or lightheadedness, headache, uncoordination, nausea, diarrhea, blood abnormalities, liver damage, kidney damage.
- Eye contact: Irritation of eyes. Prolonged or repeated contact can cause conjunctivitis, tearing of eyes, redness of eyes, severe eye irritation, corneal injury.
- Ingestion: Ingestion may cause lung inflammation and damage due to aspiration of material into lungs, mouth and throat irritation, fatigue, drowsiness, dizziness and/or lightheadedness, headache, uncoordination, nausea, vomiting, diarrhea, gastro-intestinal disturbances, abdominal pain, central nervous system depression, blood abnormalities, liver damage, kidney damage, pulmonary edema, loss of consciousness.
- Medical conditions aggravated by exposure: Eye, skin, respiratory disorders, asthma-like conditions, kidney disorders, liver disorders, nervous system disorders.

FIRST-AID MEASURES

- **Inhalation:** Remove to fresh air. Restore and support continued breathing. Get emergency medical attention. Have trained person give oxygen if necessary. Get medical help for any breathing difficulty. Remove to fresh air if inhalation causes eye watering, headaches, dizziness, or other discomfort. - **Skin contact:** Wash thoroughly with soap and water. If any product remains, gently rub petroleum jelly, vegetable or mineral/baby oil onto skin. Repeated applications may be needed. Remove contaminated clothing. Wash contaminated clothing before re-use. Dispose of contaminated leather items, such as shoes and belts. If irritation occurs, consult a physician.
- Eye contact: Flush immediately with large amounts of water, especially under lids for at least 15 minutes. If irritation or other effects persist, obtain medical treatment.

Ingestion: If swallowed, obtain medical treatment immediately.

FIRE-FIGHTING MEASURES

(ANSI Section 5)

- Fire extinguishing media: Dry chemical or foam water fog. Carbon dioxide. Closed containers may explode when exposed to extreme heat or fire. Vapors may ignite explosively at ambient temperatures. Vapors are heavier than air and may travel long distances to a source of ignition and flash back. Vapors can form explosive mixtures in air at elevated temperatures. Closed containers may burst if exposed to extreme heat or fire. Dust explosion hazard. Forms peroxides of unknown stability. May decompose under fire conditions emitting irritant and/or toxic gases.

ACCIDENTAL RELEASE MEASURES

Steps to be taken in case material is released or spilled: Comply with all applicable health and environmental regulations. Eliminate all sources of ignition. Ventilate area. Ventilate area with explosion-proof equipment. Spills may be collected with absorbent materials. Use non-sparking tools. Evacuate all unnecessary personnel. Place collected material in proper container. Complete personal protective equipment must be used during cleanup. Large spills - shut off leak if safe to do so. Dike and contain spill. Pump to storage or salvage vessels. Use absorbent to pick up excess residue. Keep salvageable material and rinse water out of sewers and water courses. Small spills use absorbent to pick up residue and dispose of properly.

HANDLING AND STORAGE

(ANSI Section 7)

- Handling and storage: Store below 80f. Store below 100f (38c). Keep away from heat, sparks and open flame. Store in original container. Keep away from direct sunlight, heat and all sources of ignition. Keep container tightly closed in a well-ventilated area. Do not allow to evaporate to near dryness. If peroxide formation is suspected, do not open or move container. Addition of water or appropriate reducing materials will lessen peroxide formation.
- Other precautions: Use only with adequate ventilation. Do not take internally. Keep out of reach of children. Avoid contact with skin and eyes, and breathing of vapors. Wash hands thoroughly after handling, especially before eating or smoking. Keep containers tightly closed and upright when not in use.
